The following Cookie Policy describes how Henley & Partners Group Holdings Ltd, Pendergardens Business Tower, Level 2, Saint Andrews Road, Paceville, Saint Julian's, Malta STJ 9023 ("H&P", "We", "Our" or "Us") uses cookies and similar technologies to collect and store information when you interact with Our website <https://thepresidentlinks.com.na/> and its web pages ("Site") or the services offered via Our Website.

What are cookies?

When you visit Our Website, open Our e-mails, or view Our services online, H&P or an authorized third party may send you a cookie. Cookies are small text files that may be placed on your device. When a website is accessed, a cookie that is placed on a device will send information to the party that has placed the cookie. Cookies are extremely common and used on a number of websites. Each cookie will typically contain the name of the domain from which the cookie has come, the "lifetime" of the cookie, and a value (usually a unique number). Information about Our use of cookies

Our Website uses cookies to distinguish from other users of Our Website. They allow Us to analyze trends and administer the Website to help Us to provide you with a good experience when you browse Our Website and to improve it at the same time.

A cookie is a small file of letters and numbers that We store on your browser or the hard drive of your computer if you agree. Cookies contain information that is transferred to your computer's hard drive. A cookie, enables the website to remember users that have already visited. Without a cookie, every time you open a new web page, the server where that page is stored will treat you like a completely new visitor. Cookies allow Us to remember your custom preferences such as your language preference and allow you to complete tasks without having to re-enter your information when browsing in order to make browsing on Our Website easier.

We use the following cookies:

- **Strictly necessary cookies:** These are cookies that are required for the optimal performance of the Website.
- **Content customization cookies:** The cookies store your country location which is used for certain features offered within the Website. This helps Us to improve the way the Website works, for example, by ensuring that users are finding what they are looking for easily.
- **Tracking cookies:** The cookies are used for the purpose of marketing campaign tracking. These cookies record your visit to the Website, the pages you have visited and the links you have followed. We will use this information to make the Website and the advertising displayed on it more relevant to your interests. We may also share this information with third parties for this purpose.

- **Third-party cookies:** These cookies allow Our Website to interact with different websites which may provide useful information.
